Requirements for application:

- 1. Completed Application Forms (if possible in English).
- 2. Valid passport.
- 3. Two (2) recent passport size photographs in colored, one photo must be attached to the application for and name must be written on the back of the photo.
- 4. Flight confirmation (Itinerary) entering and exiting Myanmar.
- 5. Self-addressed envelope with the stamps **for Registered (7.-chf) or Express (18.-chf)** mail to return the passport to the applicant. "Please consult the Post Office for the exact amount of stamps needed."
- 6. Visa fees (Cash can be sent by mail at your own risk or by depositing personally at our office. It is only payable by cash).

Note: Additional requirements for the following applicants

- 1. **Package tour (tourist visa)** invitation letter from tour operator in Myanmar is to be attached to application.
- 2. **Business visa** Verbal note from the Company or Organization in Switzerland, Invitation letter from the business partner in Myanmar, Company registration certificate of the Business/Organization in Myanmar, Curriculum Vitae in english are to be attached.
- 3. **Social Entry** invitation letter from the host in Myanmar and a copy of the passport or the National ID of the host in Myanmar to be attached to the application.
- 4. **Religious/Meditation visa-** Invitation lettre from the Meditation Center in Myanmar and Curriculum Vitae are to be enclosed.

Processing Time

Approximately 7 working days, specifically for tourist visa.

(Note: All visa which need to seek approval from respective Ministry need to submit their applications months in advance, and might take longer time as usual).
